## **CHARTER 9**

# **PENALTIES**



### Article 37: Table of fees and fines

Penalties are charged to natural and legal entities that violate the Sanitation Regulation. Specifically, for the cases of the previous articles that specify fees or entail penalties & fines, these are determined as follows; other than the aforementioned fines, the competent departments may also charge the violators with any other administrative or penal sanction provided for by the legislation in force.

<sup>\*</sup>Interested parties should first contact the refuse disposal services of the competent municipal commune (please use the telephone numbers listed in the Annex entitled: Contact with the Municipality). Then, they should submit a written request to the Municipal Revenue Directorate (Department of General Revenue Collection) containing a description of the items to be collected. These items shall be collected by appointment.

<sup>\*</sup>Electronic payment of the fees to the municipality is possible following a relevant e-request, on condition that the interested party has provided full tax identification information and a valid e-mail address.

<sup>\*</sup>If the citizen concerned lives below the poverty line, the items listed in the table above are collected free of charge.

#### Notes:

- ✓ The amounts of the fines marked with an (\*) are set out by the provisions of Law 4819/2021. For infringements of the Sanitation Regulation that are covered by Appendix IX, Part B, art. 66, par. 11 of Law 4819/2021 the Municipality shall impose the penalties foreseen by the Appendix and may also, in application of item e, par. 11 of the above article, increase the value of such penalties. The Municipality shall increase the penalties in the event of recurrence of the infringement.
- ✓ For other violations for which Law 4819/2021 does not foresee penalties, the penalty shall be decided for each violation by decision of the City Council of each Municipality (art. 79, par. 3 of Law 3463/2006, combined with item e, art. 66, par. 11 of Law 4819/2021).
- ✓ The above Regulation shall remain applicable until its subsequent amendment by the competent bodies.
